Matt Halden / CD11 (Traci Park)

Supreme court decision in Grants Pass case - impact is not yet determined. Any changes need to go through the city council. Traci asked the city attorney to create a report on how the ruling will impact the city, but it will take time. Smaller entities around LA might move faster, causing problems to be pushed into the LA jurisdiction.

12441 Verdi Street - managed by an attorney who is working with the son of the original owner. Property is owned by an LLC managed by that attorney. Eviction is working its way through the sheriff's department.

RV Task force - should be a busy summer, as CD11 is the most active district addressing RVs. Currently it takes about 5 weeks to get a response crew once an RV is called into Traci's office.

Lucerne/Sycamore properties (fire hazards): CD11 is trying to fence them off to deter squatters. Original fence now has a hole in it. Property owner is applying for demo permits.

Inglewood/90 freeway encampment - will hopefully be addressed on July 31st.

Culver Loop and baseball fields on Culver Blvd - there are some smaller encampments there which need to be addressed soon due to brush fire risk. Should be relatively quick since there are no RVs there, but it is outside CD11 jurisdiction so it requires coordination with the sheriff's office. His email is matthew.halden@lacity.org.

ADA improvements on Short/Lyceum - still waiting to hear back from the department of street services.

LAPD Carnival - one homicide happened at Venice/Overland with a group of juveniles, one was stabbed.

- Summer Night Lights programming will be held for young people and families Thursdays Saturdays 6pm-11pm
- Held listening sessions regarding the selection of our next police chief

- Re: the recent supreme court decision. Mayor Bass says that this ruling must not be used to arrest ourselves out of the homelessness problem, or to hide it. This is more expensive than actually solving the problem, by bringing people indoors with services.

Georgina Huskey / Emergency Preparedness

Will have a meeting on August 13. National Night Out booth space is available for the DRRA; motion to host a booth at NNO was approved. We should have swag like post-it notes and suggested some items for raffles.

Terrie Lavery discussed what to do when the power goes out.

- Recommends to store batteries next to the flashlight, not in it, to avoid corrosion
- You can also set "low power mode" on your cellphone to preserve the battery
- Use external batteries as a backup charge
- You can view outage status on the power company website
- Don't use old fashioned candles for light
- Don't use a gas stove to heat your house
- Make sure you will have access to your prescription drugs, especially refrigerated ones

Eddie Kurtz / Membership Committee

Will be meeting on July 10. Eddie will be meeting with Kathleen to help incorporate Wix memberships into the treasurer's report. Will bring membership forms etc to the National Night Out.

Elizabeth Pollock / Land Use Committee

Lincoln/Washington project is in the information gathering phase. Their use of the Adaptive Reuse Ordinance needs to be watched closely because the hearing was the same night as the presidential debate so not many people attended.

Planning Department is updating the community plan - they are circulating a draft plan with comments being solicited. Will have only one presentation (to the DRNC's land use committee) on Thursday July 18th so everyone is encouraged to attend.

A public hearing scheduled for July 25th on the housing element ordinance changes to allow for more housing as required by law. In particular height restrictions will be loosened.
