Hector Aceves / LAPD Pacific Division

LAPD is starting to use a new data reporting system so there are some hiccups. Overall crime is down but there is an uptick of garage thefts, and houses that are being fumigated.

Marina Marketplace: cars are being broken into. Recommends you do not leave valuables in plain view. LAPD is cooperating with their security agency.

Recent CarePlus operations: Inglewood/90 (although 1-2 RVs have returned); 12549 Culver Drive on Little Culver (working with CD11); Mesmer between Teale and Major Street is being scheduled in the near future.

Pacific Boosters Carnival will be held June 21-23 on Venice, between Overland and Motor.

National Night Out: will be held August 6th at Bill Rosenthal park.

Matt Halden / CD11 (Traci Park)

Encampment in wetlands (near Culver/90) - property owner has evicted the squatters with LAPD, and cleaned the area. Traci's office is aware of the encampment at Inglewood/90 and the fact that it has repopulated since the last CarePlus operation. Hoping to schedule another operation in July. Traci's office is aware of the person experiencing homelessness on the Culver Median, and will send a team to them some time this week. Culver/Lincoln encampment has been cleared.

Mural at Mesmer/90 - CD11 will be assisting with this proposal. Potential muralists need to be on the Dept of Cultural Affairs' list of approved muralists.

RVs at Sawtelle/Braddock: they are mobile and have been maintaining a minimum level of compliance with parking restrictions, so it is difficult to schedule cleanups for those types of RVs and cleanups may need to be scheduled repeatedly.
